## **APPLICATION TO TURFGRASS**

The use of this product will provide plant nutrients as well as providing control of selected insect pests. LESCO MERIT 0.2 Plus Turf Fertilizer can be used for the control of soil inhabiting pests of turfgrass, for example, Northern & Southern masked chafers, Cyclocephala borealis, C. immaculata, and/or C. lurida; Asiatic garden beetle, Maladera castanea; European chafer, Rhizotrogus majalis; Green June beetles, Cotinus nitida; May or June beetles, Phyllophaga spp.; Japanese beetle, Popillia japonica; Oriental beetle, Anomala orientalis; Billbugs, Sphenophorus spp.; Annual bluegrass weevil, Listronotus maculicollis. Black turfgrass ataenius, Ataenius spretulus; Aphodius spp.; crane flies, Tipula spp., and mole crickets, Scapteriscus spp.

LESCO MERIT 0.2 Plus Turf Fertilizer can be used as directed on turforass, for example, in home lawns, business and office complexes, shopping complexes, multi-family residential complexes, golf courses, airports, cemeteries, parks, playgrounds, athletic fields and sod farms.

The active ingredient in LESCO MERIT 0.2 Plus Turf Fertilizer has sufficient residual activity so that applications can be made preceding the egg laying activity of the target pests. High levels of control can be achieved when applications are made preceding or during the egg laying period. The need for an application can be based on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Optimum control will be achieved when applications are made prior to egg hatch of the target pest, followed by sufficient irrigation or rainfall to move the active ingredient through the thatch.

Do not make applications when turfgrass areas are waterlogged or the soil is saturated with water. Adequate distribution of the active ingredient cannot be achieved when these conditions exist. The treated turf must be in such a condition that the rainfall or irrigation will penetrate vertically into the soil profile. Applications cannot exceed a total of 200 lb (0.4 lb of active ingredient) per acre per year.

#### APPLICATION TO ORNAMENTALS

LESCO MERIT 0.2 Plus Turf Fertilizer can be used as a broadcast application on ornamentals in commercial and residential landscapes, as well as on landscaped areas of golf courses and other recreational areas. This is a systemic product, with the active ingredient being absorbed by the roots and translocated upward within the plant. Optimum control will be achieved when applications are followed by sufficient mechanical incorporation, irrigation, or rainfall to place the active ingredient into the soil.
